Educational Settings (S12E8)	<a href="#">Link</a>	In this episode, we discuss schools' and colleges' roles, responsibilities, and reactions to overdose, how school nurses are positioned to notice red flags and intervene early, the implementation and use of naloxone in educational settings, how colleges are training staff to respond to overdoses, and how schools are preparing themselves – and their young learners – to tackle the overdose crisis.
