# **About JCOIN**

The Justice Community Opioid Innovation Network (JCOIN) facilitates the collaboration between investigators and criminal legal system and behavioral-health partners to study and disseminate evidence-based research on treatment and best practices to improve care given to individuals with opioid use disorder (OUD) in criminal legal system settings.

Led by the National Institute on Drug Abuse (NIDA), and funded through the National Institutes of Health's (NIH) Helping to End Addiction Long-term® Initiative, or NIH HEAL Initiative®. JCOIN is a groundbreaking initiative designed to advance scientific knowledge on effective policies, practices, and interventions, and expand their use into daily practice within health and the criminal legal system.

JCOIN includes 13 clinical research centers ("Research Hub") and two resource centers that conduct complementary studies and provide supportive infrastructure: the Coordination and Translation Center (CTC) and the Methodology and Advanced Analytics Resource Center (MAARC). Together, these centers engage criminal legal system practitioners and treatment providers in research studies to address the opioid crisis and disseminate findings to stakeholders across the country.

Each study involves researchers working with the criminal legal system and health stakeholders within five or more communities to address gaps in opioid use disorder treatment and related services in a wide range of criminal legal system settings, including jails, prisons, community corrections, problem-solving courts, and juvenile justice agencies. The studies will evaluate behavioral interventions, digital therapeutics, comprehensive patient-centered treatments, and delivery of medications for opioid use disorder (MOUD) throughout the United States.

# **About the LEAP Program**

Learning Experiences to Advance Practice (LEAP) is a multifaceted program designed to educate any interested individual about the nuances of conducting research in health and criminal legal settings. The program is led by the Coordination and Translation Center (CTC), a large resource center part of the by the Justice Community Opioid Innovation Network's (JCOIN), an initiative administered by the National Institute on Drug Abuse (NIDA) and funded through the National Institutes of Health's Helping to End Addiction Long-term Initiative, or NIH HEAL Initiative.

In 2020, the CTC launched the LEAP education with two tracks: a 2-year Investigator Track and a 1-year Scholar Track. The program to support investigators and scholars with training and knowledge to conduct research and build research capacity within the criminal legal system and health settings. LEAP offers research education, mentoring, and networking, and other resources that will benefit practitioners in the areas of justice, treatment, and health, as well as scientists, researchers, journalists, and community members.

The program aims to advance the capacity and diversity of high impact research for populations involved with the health and criminal justice systems through specialized training and skilldevelopment curriculums. Specifically, the goals of the program are to:





- » Grow the research workforce with the knowledge and skills needed to conduct ethical, rigorous research including partnering with justice and health agencies to conduct rigorous studies, recruitment and enrollment of subjects, use of informed consents, and problem solving in a variety of health, community, and justice settings.
- » Enlist an array of community, health, and justice leaders to value and implement research findings in practice and to engage in collaborative research teams on the conduct of research.
- » Motivate these learners to champion completion of research projects and fidelity of planned projects given the challenges of dayto-day operations.
- » Expand and/ or develop a pipeline of independent criminal justice and health researchers for the field that can work in multidisciplinary teams

Over the past four years there have been three LEAP Investigator cohorts, with 24 participants, and four LEAP Scholar cohorts with 67 participants. The following highlights these individuals and their contributions to the fields.

# **LEAP Investigators**

The LEAP Investigator track was designed for individuals interested in a career as an independent investigator and focused on a project to be designed and carried out over two years. This track emphasized research proposal writing, grant management, mentorship, and advanced research skills needed to be successful in criminal justice settings.

A total of 24 individuals participated in three cohorts of the LEAP Investigators program.

# **MATTHEW AKIYAMA**

Matthew Akiyama, MD, MSc, is an Associate Professor of Medicine and Physician-Investigator at Albert Einstein College of Medicine / Montefiore Medical Center. In addition to providing care and treatment to people living with HIV, HCV, and substance use disorders, Dr.Akiyama conducts research focusing on HCV among socioeconomically marginalized populations with an emphasis on the intersection of HCV in the criminal justice system. Dr. Akiyama is the recipient of a K 99 / R 00 award from the National Institute on Drug Abuse (NIDA) to develop and test an innovative strategy to improve linkage to and retention in HCV treatment among individuals recently released from jail.

He is the recipient of additional NIH and institutional funding focused on HCV Transmission Networks Among People Who Inject Drugs in the Bronx, New York, and Kenya, East Africa. Dr. Akiyama is also active in policy and advocacy as a member of the New York State Governor's Hepatitis C Elimination Task Force and the Medical Director of the Hepatitis C Mentor and Support Group. Dr. Akiyama completed his Infectious Diseases Fellowship at New York University/ Bellevue Hospital Center and a Master of Science in Medical Anthropology at University College London in London, England.

# **KATHRYN M. NOWOTNY**

Kathryn M. Nowotny, PhD, is an Associate Professor at the University of Miami Department of Sociology. Her research uses both quantitative and qualitative methods to examine the multilevel factors that create an increased risk for poor health among justice-involved people. Dr.Nowotny is currently a Site-Principal Investigator and Co-Investigator of a multi-site longitudinal cohort study examining barriers to pre-exposure prophylaxis (PrEP) for HIV prevention among individuals under community supervision in the South (NC, FL, KY).

She is also the Principal Investigator of a Center for HIV and Research in Mental Health (CHARM) funded project exploring the syndemic pathways to suboptimal care for justice-involved patients living with HIV, and Co-Investigator of a binational study investigating how the migration process influences health, including experiences with immigration enforcement and confinement to detention centers.

# **PETER TREITLER**

Peter Treitler is an Assistant Professor at the Boston University School of Social Work. His research aims to improve the well-being of people with substance use disorders and inform more effective solutions to the nation's critical substance use challenges. His work examines the implementation and outcomes of health services for people with substance use disorders and how federal, state, and payer policies shape their treatment and recovery experiences. With the goal of improving treatment across the health system, Treitler studies interventions that engage individuals in correctional facilities, emergency departments, and primary care clinics, as well as the policies that support implementation in these settings. Treitler's research uses mixed-methods, combining analyses of large administrative datasets such as Medicare and Medicaid claims with qualitative perspectives from service users, providers, and policymakers.

## **TALEED EL-SABAWI**

Dr. El-Sabawi is an interdisciplinary scholar with a JD and a PhD in Public Health, Health Services Management, and Policy with a doctoral cognate in Political Science. She specializes in using qualitative and quantitative methods to analyze texts, including congressional hearing testimony, regulations, legislation, news media, political speeches, and interview transcripts. Her area of expertise is in addiction (harm reduction) and mental health policy, politics, and law. Dr. El-Sabawi has studied and written extensively on the narrative discourse surrounding opioid overdose deaths; federal administrative regulation of potentially habit-forming substances; and health insurance parity. Recently, Dr. El-Sabawi co-authored a model law that creates non-police behavioral health crisis response teams and has contributed to model laws commissioned by the Office of National Drug Control Policy.

Dr. El-Sabawi has provided technical assistance to federal, state, and local policymakers on the adoption of evidence--based policy to address behavioral health issues. She is a member of the advisory circle of the North Carolina Urban Survivors Union, a chapter of the Urban Survivors Union, on the Board of Directors for Next Distro, and frequently works alongside harm reduction activists and persons who use drugs advocating for policy reform.

## **ANGELA STEVENS**

Angela Stevens, PhD, MPH, is a clinical psychologist and a postdoctoral research fellow at the Brown University Center for Alcohol and Addiction Studies. She pursues her line of research using both qualitative and quantitative methods, with the latter leveraging ecological momentary assessment (EMA) and advanced multilevel modeling.

Dr. Stevens is an expert in alcohol and cannabis co-use behavior, and this expertise has spearheaded her current focus on understudied alcohol/ drug and drug/ drug combinations that are potentially lethal when co-ingested (e.g., alcohol and opioids, alcohol and benzodiazepines). Given research using EMA to understand these particular drug combinations is in its nascent stages, she is currently focused on better understanding this phenomenon using qualitative interviews, which will guide a subsequent study designed to test etiological risk factors and consequences of high-risk simultaneous polysubstance use in daily life.

Through the JCOIN LEAP Investigator program, she conducted similar research with justice-involved individuals post-release, which is a particularly vulnerable time for overdose.

# **GRANT VICTOR**

Grant Victor, MSW PhD, utilizes both qualitative and quantitative methods in his research to assess system- and individual-level factors that increase the risk of poor health outcomes (e.g., overdose) and criminal/ legal outcomes (e.g., arrest & recidivism). These methodological approaches include the linking of administrative data from EMS, county jails, toxicology, and vital records to examine the impact of jail on community behavioral health.

Pursuant to the goal of meaningfully involving community stakeholders in all stages of the research process, he collaborates with community-based organizations to align his research with the community's priorities. Through support from foundational and state funding mechanisms, Grant is involved with several community-based research initiatives with county- and state-level stakeholders across multiple systems, including harm reduction agencies, courts, police, community mental health agencies, jail staff, and medical providers, among others.

To date, much of this work has concentrated on how individuals' encounters with the criminal/ legal system and medication therapies moderate the risk of fatal and nonfatal overdose events. Grant has also evaluated the role of peer recovery support as part of the community re-entry planning for justice-involved individuals.

# **LISA INGARFIELD**

Lisa Ingarfield, PhD (she/her), has over 17 years of experience in sexual assault response and prevention in Colorado, working in higher education and state government. She earned her PhD in Communication Studies (Critical Intercultural Communication) from the University of Denver in 2014. Her research focused on sexual violence victim advocacy and the manifestation of bias in advocacy relationships.

Dr. Ingarfield has since begun to focus on the intersection of health and criminal justice for sexual assault survivors, particularly their access to Sexual Assault Nurse Examiner programs. She is currently the principal investigator on two federal research and evaluation grants focusing on sexual assault response. The first evaluates the efficacy of forensic compliance laws to identify gaps and opportunities for stakeholders to better ensure survivors of sexual assault understand their reporting options and have ready access to medical forensic exams. The second project is an evaluation of an innovative policing solution to address sexual violence – a cross-jurisdictional sexual assault task force with embedded victim services and community collaboration.

# **KELSEY JAYNE PASCOE**

Kelsey Pascoe, PhD, RN, is an Assistant Professor of Nursing at Washington State University and a Registered Nurse at Seattle Cancer Care Alliance. Dr. Pascoe conducts research focusing on the impacts of incarceration on individuals and partners or families. Previously, she conducted research inside prisons, focusing on increasing self-efficacy in the management of symptoms of chronic diseases or health promotion. Additionally, she conducted a study at a jail focused on understanding the barriers to accessing primary care immediately following jail release and offering a warm hand-off intervention in hopes of overcoming some of those barriers.

Currently, Dr. Pascoe is seeking funding for a similar project focused on improving access to perinatal care for pregnant women being released from jail in a few counties in Washington State. Her goal is to understand the impacts of incarceration on the pregnancy experience and to identify the impact that early enrollment in prenatal care prior to jail release will have on engagement with prenatal care, readiness for parenthood, and social needs of the mother and baby. By engaging at-risk mothers in appropriate prenatal care prior to release, this project hopes to improve the health and well-being of both mothers and their children for years to come.

# **MEGHAN NOVISKY**

Dr. Meghan Novisky is an Assistant Professor of criminology in the department of criminology, anthropology, and sociology at Cleveland State University. She is an interdisciplinary, multi-methods scholar with broad research interests in carceral policy, inequalities, and health. One of her research aims is to encourage the use of evidencebased practices in corrections. To that end, she has worked as a consultant for the University of Cincinnati's Corrections Institute for over ten years, where she trains correctional staff on effective, research-informed programming. Most recently, and in response to the COVID-19 pandemic, she has partnered with the ACLU of Ohio by drafting expert declarations to urge the release or transfer of vulnerable incarcerated adults in prisons and jails.

Meghan's current projects involve collaborating on two multi-methods studies on incarceration-related experiences during the COVID-19 pandemic. One project assesses familial experiences with incarceration during the pandemic, and the second seeks to understand stakeholder perspectives on compassionate release use during COVID-19. She is also partnering on a qualitative project that relies on focus group methodology to explore perspectives on health care access among both incarcerated older adults and their peer caregivers.

## **GLORIMAR CARABALLO-**CORREA

Glorimar Caraballo-Correa, PhD, is an Adjunct Professor and Evaluator at the Graduate School of Public Health and the School of Medicine at the University of Puerto Rico. Her research work and interests are focused on health services access and utilization, transition of care from prison to community, and stigma towards vulnerable populations such as drug users and prisoners. The expansion of medication-assisted treatment is one of her main interests. Dr. Caraballo-Correa has been involved in research projects that explored the factors associated with access to medication-assisted treatment, focusing on persons exiting prison. On a second research line, she is also working with factors associated with children being removed from their homes due to their parent's drug use. # **ESTHER MATTHEWS**

Esther Matthews, PhD, is an Assistant Professor of

Criminology at Gonzaga University. Her research focuses on punishment, incarceration, and reentry, with a special interest in how continuity of care impacts a variety of reentry outcomes. Additionally, Esther uses survey experiments to better understand how public stigma impedes successful reentry for people with health challenges and histories of incarceration. She has conducted ethnographic investigations of prison life, including extended visits to several prison solitary confinement units designed for individuals who experience mental health challenges. Esther has also evaluated various reentry programs designed to support people returning to their communities.

Esther's research has been featured in the Journal of Offender Rehabilitation and the Washington Post, with several publications under review. One of her current projects includes an investigation into the reentry outcomes of individuals who had a life sentence commuted or overturned, with a special focus on access to physical and mental health care. Esther uses her lived experience in the criminal legal system, along with her academic training, to provide a rich, authentic, and humane understanding of the criminal legal system.


# **TESS K. DRAZDOWSKI**

Brandon served for 23 years as a police officer. His years of patrol created a desire in him to improve police response to substance use disorder. He partnered with researchers across the nation to devise evidence-based strategies centering on harm reduction and the widespread, lowthreshold availability of medications for opioid use disorder (MOUD), especially buprenorphine.

After completing his doctoral work on the role of the police in a democracy, Brandon was inspired to further pursue the science needed to address the overdose crisis: MOUDs have long proven effective at saving lives, but they remain greatly underutilized. Realizing our nation's systems of care and public administration are not utilizing medication for opioid use disorder effectively in a time of profound crisis inspired Brandon to turn toward scientific research about bridging this critical gap, especially in policing and other criminal justice settings. He, therefore, embarked on a postdoctoral research fellowship on substance use at The Miriam Hospital/ Brown University.

Katherine is currently collaborating on several other projects across institutions and is open to new connections.

## **STEPHANIE GRACE PROST**

Stephanie Grace Prost's research interests and trajectory in criminal justice and health include three related areas.

First, she is interested in describing the health and quality of life of older adults who are incarcerated. Her studies contributed to reporting significant cohort effects regarding health among older men, distinct risks of post-traumatic stress across varying forms of interpersonal victimization among older women, and health-related consequences of trust among older men.




