






## "Prison and Jail Staff"

## **Episode Overview**

In this episode, I talk about prison and jail staffs' roles, responsibilities, and reactions to overdose. From 2001 to 2018, overdose deaths in state prisons rose by more than 600% and overdose deaths in county jails increased by more than 200%. I talk about the various harm-reduction strategies that have been implemented in prisons and jails, including how staff feel about these strategies. I also discuss the emotional toll overdose deaths take on staff.



- 15% of Canadian correctional staff reported encountering fentanyl or carfentanil at least once a month, and 7% responded to an overdose monthly.
- Naloxone vending machines have been implemented in some Michigan jails, which has led to a 63.5% increase in naloxone distribution.

## **TAKEAWAYS**

- Harm-reduction strategies like naloxone distribution, overdose prevention sites, and needle exchange programs save lives, but often face resistance from staff.
- Staff attitudes towards harm reduction can shift with increased education and training. Understanding how these tools can improve safety, for both incarcerated individuals and staff, is key to acceptance and implementation.
